EU DEBATE AND PRISON VISIT BOOST CHAMBER NETWORKING CALENDAR

With an EU referendum only weeks away, and conflicting information from both sides, an additional networking meeting to the Chamber calendar will ensure that local individuals and businesses will be able to make an informed vote.

An EU Referendum Debate, which will be held at 6pm on Thursday 26th May at Shrewsbury College's London Road-based Origins Restaurant and Clayton Hall, will be compered by Eric Smith of BBC Radio Shropshire. Panelists who have so far agreed to air their views include local Shrewsbury & Atcham MP Daniel Kawczynski and Suzanne Evans (who both support the 'Leave' campaign), and Arthur Hill (Shropshire Business Board) and Sam Fowles (Another Europe is Possible) (who support remaining in Europe). Members of the Chamber have a chance to put forward their questions before the event.



Meanwhile, a number of other events are on the horizon, including a tour of Salop Design's new training facility (April), a presentation by Shropshire Council's Chris Taylor about broadband investment (May), a tour of Shrewsbury Prison and buffet organised by Jailhouse Tours (June), and the ever-popular Shrewsbury Flower Show Networking Breakfast (August), which last year attracted 60 guests.

Members, guests and non-members are welcome to Chamber events; non-members are generally asked for a small fee to cover administration and catering charges (excludes the referendum debate). Attendees at all networking events must complete registration, via the events page on our website www.shrewsburybusiness.com, or by emailing info@shrewsburybusiness.com.

NEW ARMY CADET FORCE FOR SHREWSBURY COLLEGE

The Shropshire Army Cadet Force (ACF) is set to form a new Platoon at Shrewsbury College from September. Staff Sergeant Instructor Gray from Shropshire ACF, will run the Shrewsbury College Platoon (RIFLES), which will parade on a Wednesday afternoon from 2–4pm at the College on London Road, as part of the College's already vibrant enrichment programme.

A special recruitment event will be held at the College along with the Army Reserve Platoon on 6th July from 9am to 1pm, as part of the College's Welcome Event for students starting this September. As part of the merger proposal, all students aged 16-18 from Shrewsbury College, Shrewsbury Sixth Form College and New College Telford are invited to participate. Shrewsbury College staff will also be invited to be trained and contribute to the cadet force.

Principal for Curriculum and Operations, said: "Our Enrichment programme is an important part of every student's time at the college. It aims to provide our students with a wealth of different learning and leisure activities, which enhance their chosen subjects, enrich

We aim to launch the Platoon on 5 September, 2016 during the College's induction week, and will be busy informing all current

The Army will be informing current Senior Cadets that should they be moving to Shrewsbury College to study in September, they can transfer to the new Platoon.

SSI Gray said: "Being an Army Cadet means that you get to do lots of activities you wouldn't normally do, we will teach you leadership skills, discipline and give you self-confidence you never thought possible. You will learn a wide range of transferable skills such as the ability to

"Our annual conference is about how we are Meeting the Challenges and also a chance for us to actively engage with businesses in the programme of work we are tasked with to



FLYING START TO 12 CHALLENGES

A son's mission to raise £8,000 for Macmillan Cancer Support, to say thank you to the charity for supporting his father who is battling terminal cancer, has got off to a flying start as he prepares for his next challenge. Max Ball, 24, a marketing assistant at Shrewsbury-based caravan dealership Salop Leisure, has set himself 12 different sponsored challenges – MaxAndTheMac12 – during 2016. He has already taken on a solo bungee jump at Tamworth Bungee Club in February and was joined by workmates Emily Ridge and friend Ash Peille for the Dash of the Titan mud run in Nottinghamshire.

The challenges to date have raised £3,467, which includes a £1,200 contribution from Salop Leisure workmates Tony Cooke and Ed Glover, who took part in the 2016 Macmillan 4x4 Challenge. Next up is a team challenge where Max, with Salop Leisure workmates Scott Higgins and Chris Evans and friends John Marshall and Steve Drury, will take on local motor dealership group Greenhous in a race to sit on half the 9,875 seats in Shrewsbury Town's Greenhous Meadow stadium. Both teams are being sponsored for the challenge with all the money going to Macmillan Cancer Support.

Max is also preparing to perform a scene from 'Much Ado About Nothing' in The Square in Shrewsbury for Shakespeare Day on April 23. There will also be a Shakespeare themed treasure hunt with a poem leading hunters to different places in the town. Performances will take place throughout the day and volunteers from Macmillan Cancer Support will be collecting donations.

Salop Leisure is organising a charity football match against Greenhous at the Greenhouse Meadow Stadium on May 13, with the motor company out to avenge a 3–1 defeat last year. Other events in the challenge series are the Rough Runner Challenge on May 15, Shrewsbury Half Marathon on June 19, the National Three Peaks Race from July 1–3, a foot golf tournament on July 24, white water rafting in Llangollen and a 24–hour squashathon at Kingsland Squash Club, Shrewsbury in August, Shrewsbury Sprint Triathlon on September 4 and a 106–km ride at Ludlow Cycling Festival on September 18. As an extra fundraiser, he's planning a bake-off at Salop Leisure to coincide with Macmillan's World's Biggest Coffee Morning on September 30.

LANYON BOWDLER MENTORS STUDENTS IN DEBATING SKILLS

Dozens of students came together for a debating competition as part of a new project set up by a trainee solicitor at a Shropshire law firm.

Holly Edwards, who works at Lanyon Bowdler Solicitors, created the Debate-Ed programme for sixth form students to mentor school pupils to develop their debating and presenting skills. The competition took place at Shrewsbury Sixth Form College with students

from Adams Grammar School, Meole Brace and Prestfelde School taking part.

A team from Adams Grammar School were the overall winners and they were presented with a trophy, donated by Lanyon Bowdler Solicitors, who had sponsored the programme and provided support and resources towards its development.

Judge Jim Tindal and Shrewsbury's Mayor, Councillor Miles Kenny, both sat on the judging panel for the competition and gave the children words of encouragement.

Shrewsbury and Atcham MP, Daniel Kawczynski, spoke to the students to give them advice and tips, and members of staff from Lanyon Bowdler also provided support. Four rounds of debating took place with the final being held in the main hall in front of more than 50 people, on the topic of whether the Government should introduce a sugar tax.

Holly, who launched Debate-Ed back in September, said the project had been a great success. She said: "A huge well done to everyone who took part, impressing the judges with their critical thinking and speaking

skills. Giving students the opportunity to talk about interesting topics over a number of sessions has really helped build their confidence and encouraged them to think more deeply about current issues in the world."

Judge Jim Tindal praised the students debating skills, saying: "Everyone who participated in this competition has reason to feel proud. "The quality of debating was very high, remarkably so with some of the younger

competitors. And some of the best debaters would be capable of conducting a simple court trial now. They were that good."

In total, more than 100 pupils have participated in the Debate-Ed workshops.

Holly added: "We have had some great feedback from the pupils. Debating skills are very important for a law career, but whatever job you do, the ability to be analytical and see things from different points of view is hugely useful. I used to do debating at university and was part of the Debate Mate programme,

which runs debating sessions with schools in big cities across the UK. When I came back to Shropshire, I was keen to set something up with schools here, and approached Shrewsbury Sixth Form College with the idea of some students becoming mentors and it's gone from there."
